

1. Policy Provisions

1.1 Objective

SOLEK Group is providing business in the renewable energy sector. With a focus on solar power, it develops, builds, owns, operates, and maintains solar power plants across the European and Latin American continents. Its mission is to build 500 MW of installed solar energy capacity by the year 2023. Global energy demand for renewable sources of energy indicates constant growth.
